

Legally binding purchase contract

between

Alay (United States)

hereinafter referred to as the Seller

and

Torsten (Germany)

hereinafter referred to as the Buyer

about

Claims of the YieldNodes Masternode Pool, which is operated by Exceptional Media Limited, a company incorporated in Hong Kong under company number 1233513 with registered address at Block A, 15/F, Hillier Commercial Bldg. 65-67 Bonham Strand East, Sheung Wan, Hong Kong, hereinafter referred to as the Operator.

§1 Subject matter of the contract

The Seller hereby sells its claims, which correspond to an investment value of zzzz.zz Euro to the Buyer with a discount of pp %.

§2 Claims of the Buyer

The Seller hereby transfers all claims arising from this investment to the Buyer. The Buyer acquires 100% of the claims.

§3 Status of the claims

The Buyer is aware that all pay-out claims relating to the investment are currently suspended. As part of a restructuring based upon the DECENOMY ecosystem, it is planned that income from the deposit can be generated again by the end of 2023. It is further planned that the deposit will be converted into a Non-Fungible Token (NFT), which can be traded, by Q2/2023.

§4 Claim transfer and disclosure of address data.

The operator has checked the complete address and personal data of both parties through KYC verification.

Upon proof of payment, address data will be disclosed to both parties within 48 hours and ownership transfer will be performed in the YieldNodes portal.

The Buyer will provide proof of payment to the Operator by communicating the corresponding Blockchain transaction id/number.

§5 Disclaimer of the Seller

The Seller guarantees that he is the legal owner of the deposit. Beyond that, the Seller does not assume any guarantees or liabilities.

§6 Disclaimer of the Operator

The Operator only provides the platform enabling sellers and buyers to locate each other and conclude a corresponding contract. The Operator does not receive any payment or other benefit for providing this service. No guarantees are assumed by the Operator as any contract processed through the platform arises from the free will of both Seller and Buyer.

§7 Severability

If a provision of this agreement is or becomes legally invalid in any jurisdiction, or if there is some omission, the validity of the remainder of the agreement shall not be affected thereby. An invalid provision shall be replaced by common consent with such provision being as close to the intention of the invalid provision as possible. In the event of omission, such provision shall come into force by common consent and be as close to the intention of the agreement as possible had the matter been considered in advance. Any changes of or amendments to this Agreement must be in writing to and accepted by all parties in order to become effective.


